Tariff Plan charge is inclusive of Service Tax @10.30%. Circles can suitably adjust the plan charge in the price band upto Rs 3(+/-) of above price considering technical feasibility

Note

1. In case the defect in RUIM is beyond the control of the customer ,the new RUIM is to be provided free of cost from BSNL,CSC.
2. In case defect or loss of RUIM is due to customer negligence, Rs.20 is to be recovered for the replacement of the RUIM.
3. The same charge of Rs.20 will also be applicable in case of reactivation of closed connection after GP-II in case of prepaid services and after permanent closure due to non payment in case of postpaid services

Lifetime validity means the license period i.e. Feb-2020 or upto renewed license period. To continue with lifetime validity benefit, recharge/top-up with minimum of Rs.200 in every 180 days will be required. Although for promotional period of 90 days w.e.f. 07.10.2010 the Minimum Recharge condition for life time plans has been reduced from Rs. 200 to Rs. 49(MRP Rs. 54 inclusive of S. Tax)

In case of Assam, J&K and North East LSAs, extension of validity is subject to the guidelines/instructions issued by Govt. of India/Regulatory Authority from time to time.

After tariff validity of 365 days, the customer will automatically be migrated to base tariff Plan i.e., Option I.
